**RELEASE OF TRADEMARKS SECURITY AGREEMENT**

This RELEASE OF TRADEMARKS SECURITY AGREEMENT (the “**Release**”) is effective as of the 19<sup>th</sup> day of May, 2023, by and between:

**INSTOR SOLUTIONS, INC.**, a California corporation, having an address of 44053 S. Grimmer Boulevard, Fremont, CA 94538 (“**Grantor**”), and

**DUKE ROYALTY LIMITED**, having an address of 4th Floor West Wing Trafalgar Court Admiral Park, St Peter Port, Guernsey GY1 2JA (the “**Lender**” and “**Collateral Agent**”).

**W I T N E S S E T H:**

A. Grantor and Collateral Agent entered into that certain Loan Agreement dated as of March 6, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the “**Loan Agreement**”).

B. Grantor and Collateral Agent entered into that certain Pledge and Security Agreement dated as of March 6, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), pursuant to which the Grantor granted certain interests in favor of the Collateral Agent.

C. Grantor and Collateral Agent are parties to that certain Trademarks Security Agreement dated as of March 6, 2023, which was recorded with the United States Patent and Trademark Office (“**PTO**”) on March 7, 2023, Reel 7995, Frame 0840 (the “**Trademarks Assignment**”).

D. Grantor has satisfied all of the Secured Obligations under the Loan Agreement and the Security Agreement and requested that the Collateral Agent terminate and release its security interests in and liens on the Collateral.

NOW, THEREFORE, in consideration of the mutual covenants and agreements set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, it is hereby agreed that:

1) **Definitions**. All capitalized terms not defined in this Release shall have the respective meaning given to them in the Loan Agreement or the Security Agreement or the Trademarks Assignment, as the case may be.

2) **Termination and Release of Security Interest**. The Collateral Agent hereby terminates, releases, and discharges its security interest in and liens on the Collateral, including, without limitation, the Trademarks listed on **Exhibit A** hereto, and the Collateral Agent hereby assigns and transfers to the Grantor, without representation, warranty or recourse, all of the Collateral Agent’s right, title and interest in and to such Trademarks, effective as of the date set forth above.

IN WITNESS WHEREOF, the Collateral Agent has executed this Release effective as of the date written above.
