TERMINATION OF TRADEMARK SECURITY AGREEMENT

This TERMINATION OF TRADEMARK SECURITY AGREEMENT, dated as of May 23, 2023 (this "Termination and Release"), is granted by WELLS FARGO BANK, NATIONAL ASSOCIATION, a national banking association, as administrative agent (the "Administrative Agent") for the Lenders, in favor of BESTPASS, INC., a New York corporation (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of November 21, 2022 (the "Trademark Security Agreement"), made by the Grantor and acknowledged and agreed to by the Administrative Agent, a security interest (the "Security Interest") was granted in certain Trademark Collateral, and the Trademark Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on November 22, 2022, at Reel 7901, Frame 0093; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the Trademark Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Administrative Agent hereby agrees as follows:

1. Definitions. Capitalized terms used but not defined herein shall have the meaning provided by reference in the Trademark Security Agreement.

2. Release of Security Interest. The Administrative Agent hereby irrevocably terminates, releases and discharges the entirety of its Security Interest in the Trademark Collateral, and any right, title or interest the Administrative Agent may have in such Trademark Collateral, including, without limitation, with respect to the Trademark Collateral listed on Schedule I attached hereto. To the extent the Administrative Agent has acquired any right, title, or interest in the Trademark Collateral, the Administrative Agent hereby irrevocably assigns to the Grantor all such right, title, and interest.

3. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby, all at the Grantor's sole cost and expense.


4. Governing Law. This Termination and Release shall be governed by and construed in accordance with the laws of the State of New York.
