Pursuant to Section 17-16-1102 of the Wyoming Business Corporation Act (the "WBCA") and Section 17-16-1002 of the Wyoming Limited Liability Company Act (together with WBCA, the "Acts"), the undersigned submits the following Articles of Merger for the purpose of effecting a merger under the Acts:

1. The name and jurisdiction of formation of each of the constituent entities are as follows:

voestalpine Railway Systems Nortrak Inc. (the " <u>Company</u> ")	Corporation	Wyoming

2. An Agreement and Plan of Merger (the "Plan of Merger") has been duly approved and adopted by each of the sole shareholder of the Company and the sole member of the Surviving Company in accordance with the applicable provisions of the Acts.

3. Pursuant to the Plan of Merger, the Company shall be merged with and into the Surviving Company (the "Merger"), with the Surviving Company continuing as the surviving company of the Merger.

4. The articles of organization of the Surviving Company in effect at the effective time of the Merger shall be the articles of organization of the surviving company until thereafter amended as provided therein or by the Wyoming Limited Liability Company Act.




