- SECOND: The Charter of the Limited Liability Company is hereby amended as follows:

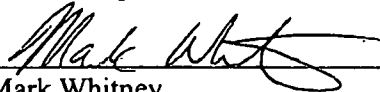
The new name of the Company is: **Vibrantz Specialty Products LLC**
