NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of July 31, 2020, executed by or on behalf of WELLS FARGO BANK, NATIONAL ASSOCIATION ("Bank"), releasing all security interest of Bank in the Trademark Collateral (defined below) owned by ROMBAUER FAMILY PARTNERSHIP II, L.P., a California limited partnership ("Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Grant of Trademark Security Interest dated as of August 23, 2013 (the "IP Security Agreement"), Grantor assigned, transferred and conveyed to Bank, and granted Bank, a security interest in all of Grantor's right, title and interest in and to the Trademark Collateral (as defined in the IP Security Agreement, the "Trademark Collateral");

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office at Reel 5100, Frame 0842; and

WHEREAS, Bank has agreed to release its lien on all of the Trademark Collateral, including but not limited to, the trademarks and trademark applications listed on Schedule A hereto (collectively, the "Released Trademark Collateral").


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Bank hereby covenants and agrees as follows:

1. Bank's mortgage, pledge, and hypothecation and lien on and security interest in the Released Trademark Collateral is hereby terminated and released.
2. To the extent Bank retains any such interest, Bank hereby assigns, transfers and conveys to Grantor, all of Bank's right, title and interest, now owned or hereinafter acquired, that it may have whether by assignment or otherwise, in and to any mortgage and continuing security interest and collateral assignment in the Released Trademark Collateral. Such assignment, transfer and conveyance by Bank is made without any representation or warranty (express or implied) by Bank.
3. Bank hereby agrees to execute, acknowledge and deliver all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release, all at the expense of Grantor. Bank authorizes Grantor (or their agents) to file such documentation as is necessary to effect the releases of the Trademark Collateral granted hereunder.
4. Delivery of an executed signature page to this Release by facsimile or other electronic transmission shall be effective as delivery of a manually executed signature page of this Release.
