## TRADEMARK ASSIGNMENT

Assignor represents, warrants and covenants that Assignor is the owner of the entire right, title and interest in and to the mark, and that Assignor has full power to make this Assignment. Assignor authorizes the Commissioner of Trademark to record and register this assignment upon request of Assignee.
