**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks, dated as of May 31, 2023 (the “Trademark Security Release”), is made by Wells Fargo Bank, National Association, as Administrative Agent for the Secured Creditors pursuant to the Loan Agreement (as defined below) (in such capacity, the “Agent”), in favor of National Amusements, Inc., a Maryland corporation (the “Grantor”). Capitalized terms used and not defined herein have the meanings given to such terms in the Loan Agreement and the Collateral Agreement (each, as defined below), as applicable.

WHEREAS, the Grantor, the Guarantors party thereto, the Lenders party thereto and the Agent entered into that certain Revolving Loan Agreement, dated as of March 26, 2020, as amended and restated as of November 17, 2022 and as further amended as of February 24, 2023 (as amended, amended and restated, extended, supplements or otherwise modified through the date hereof, the “Loan Agreement”), pursuant to which the Lenders severally agreed to make Loans and other extensions of credit to the Grantor upon the terms and subject to the conditions set forth therein;

WHEREAS, in connection with the Loan Agreement, the Grantor and the other Guarantors executed and delivered a Collateral Agreement, dated as of March 26, 2020, in favor of the Agent (the “Collateral Agreement”);

WHEREAS, pursuant to the Collateral Agreement, the Grantor granted to the Agent for the benefit of the Secured Creditors a continuing security interest in certain Intellectual Property, including the Trademarks (collectively, the “Trademark Collateral”);

WHEREAS, in connection with the Collateral Agreement, the Grantor executed and delivered that certain Trademark Security Agreement dated as of June 22, 2020 made by and between the Grantor and the Agent (the “Trademark Security Agreement”) for recording with the United States Patent and Trademark Office;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on June 24, 2020 on Reel 6977 Frame 0965; and

WHEREAS, in connection with the payment and discharge of all Obligations of the Grantor and the other Loan Parties and the termination of all Commitments under the Loan Agreement, the Grantor has informed the Agent of its desire that the Agent, on behalf of the Secured Creditors, release all right, title and interest granted to it, for the ratable benefit of the Secured Creditors, in and to the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Agent hereby agrees as follows:

1. The Agent hereby releases, terminates and discharges to the Grantor (a) the Agent’s continuing security interest in, right of setoff against and Lien on, and (b) any of the Agent’s other rights, title or interest of any kind or nature in, to or under, the Trademark Collateral, including, without limitation, the Trademarks listed on Schedule 1 hereto.


2. The Agent hereby authorizes and acknowledges the termination of the Trademark Security Agreement. At Grantor's expense, the Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the security interest contemplated hereby and terminate the Trademark Security Agreement.

3. This Trademark Security Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery of an executed counterpart of a signature page to this Trademark Security Release by facsimile will be as effective as delivery of a manually executed counterpart of this Trademark Security Release.
