**ASSIGNMENT OF
GRANTS OF SECURITY INTEREST IN TRADEMARKS**

THIS ASSIGNMENT OF GRANTS OF SECURITY INTEREST IN TRADEMARKS (this "Assignment") is made and entered into as of May 23, 2023 by Jefferies Finance LLC, as the resigning Collateral Agent (in such capacity, the "Resigning Collateral Agent"), in favor of Wilmington Trust, National Association, as the successor Collateral Agent (in such capacity, the "Successor Collateral Agent").

W I T N E S S E T H

WHEREAS, the Resigning Collateral Agent is party to that certain US Security Agreement, dated as of April 12, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "US Security Agreement"), among Instant Brands Holdings Inc., a Delaware corporation (the "Borrower"), Instant Brands Acquisition Intermediate Holdings Inc., a Delaware corporation, the other grantors party thereto, and the Resigning Collateral Agent;

WHEREAS, pursuant to (i) the US Security Agreement, and (ii) the US Trademark Security Agreement, dated as of April 12, 2021 (as amended, restated, supplemented or otherwise modified from time to time, the "Trademark Security Agreement"), made by the Borrower, Instant Brands LLC (formerly known as Corelle Brands LLC), a Delaware limited liability company ("Instant Brands"), and Corelle Brands(GHC) LLC, a Delaware limited liability company ("Corelle GHC", and together with the Borrower and Instant Brands, the "Grantors") in favor of the Resigning Collateral Agent, which was recorded at the United States Patent and Trademark Office (the "USPTO") on April 13, 2021, at Reel 007253/Frame 0820, the Grantors have granted to the Resigning Collateral Agent a continuing security interest in, and lien on, all of their right, title and interest in, to and under the Trademark Collateral (as such term is defined in the Trademark Security Agreement), including, without limitation, those trademark registrations and applications set forth on Schedule I hereto;

WHEREAS, pursuant to that certain Successor Agent Agreement, dated as of May 23, 2023 (as amended, restated, supplemented or otherwise modified from time to time, the "Successor Agent Agreement"), among the Grantors, the other Loan Parties party thereto, the Resigning Collateral Agent, the Successor Collateral Agent, and the Lenders party thereto, the Resigning Collateral Agent has resigned as administrative and collateral agent under the Credit Agreement (as defined in the US Security Agreement) and the other Loan Documents (as defined in the US Security Agreement), and the Successor Collateral Agent has assumed and succeeded to all of the rights, powers, privileges and duties of the Resigning Collateral Agent as administrative and collateral agent thereunder; and

WHEREAS, the Resigning Collateral Agent and the Successor Collateral Agent desire to enter into this Assignment to evidence the assignment by the Resigning Collateral Agent to the Successor Collateral Agent of all of the Resigning Collateral Agent's right, title and interest in, to and under the US Security Agreement and the Trademark Security Agreement, including, without limitation, the Resigning Collateral Agent's security interest in, and lien on, the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Resigning Collateral Agent and the Successor Collateral Agent hereby covenant and agree as follows:

1. Terms. Capitalized terms used in this Assignment and not otherwise defined herein shall have the meanings specified in the US Security Agreement.
2. Assignment. The Resigning Collateral Agent hereby transfers, assigns, grants and conveys to the Successor Collateral Agent for the ratable benefit of the Secured Parties all of its right, title and interest in, to and under the US Security Agreement and the Trademark Security Agreement, including, without limitation, its security interest in, and lien on, the Trademark Collateral, and the Successor Collateral Agent hereby accepts and assumes the foregoing assignment and all of such right, title, interest, security interests and liens. This Assignment is being executed and delivered in accordance with and shall be governed by the Credit Agreement, the US Security Agreement, and the Successor Agent Agreement.
3. Recordation. Effective upon the date first written above, the Resigning Collateral Agent authorizes and requests that the USPTO record the Successor Collateral Agent as the successor collateral agent for the Secured Parties in the Trademark Collateral.
4. Governing Law. This Assignment shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles which would require the application of the laws of another jurisdiction.
5. Counterparts. This Assignment may be executed in counterparts, each of which shall constitute an original and all of which taken together shall constitute one and the same instrument. Delivery of an executed counterpart of a signature page to this Assignment by facsimile transmission or electronic mail shall be as effective as delivery of a manually executed counterpart of this Assignment.


