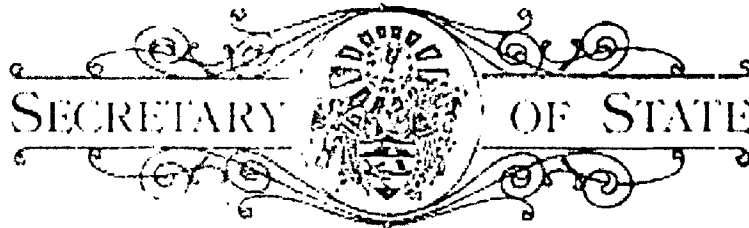


## CERTIFICATE OF AMENDMENT TO ARTICLES OF ORGANIZATION for Limited Liability Company
