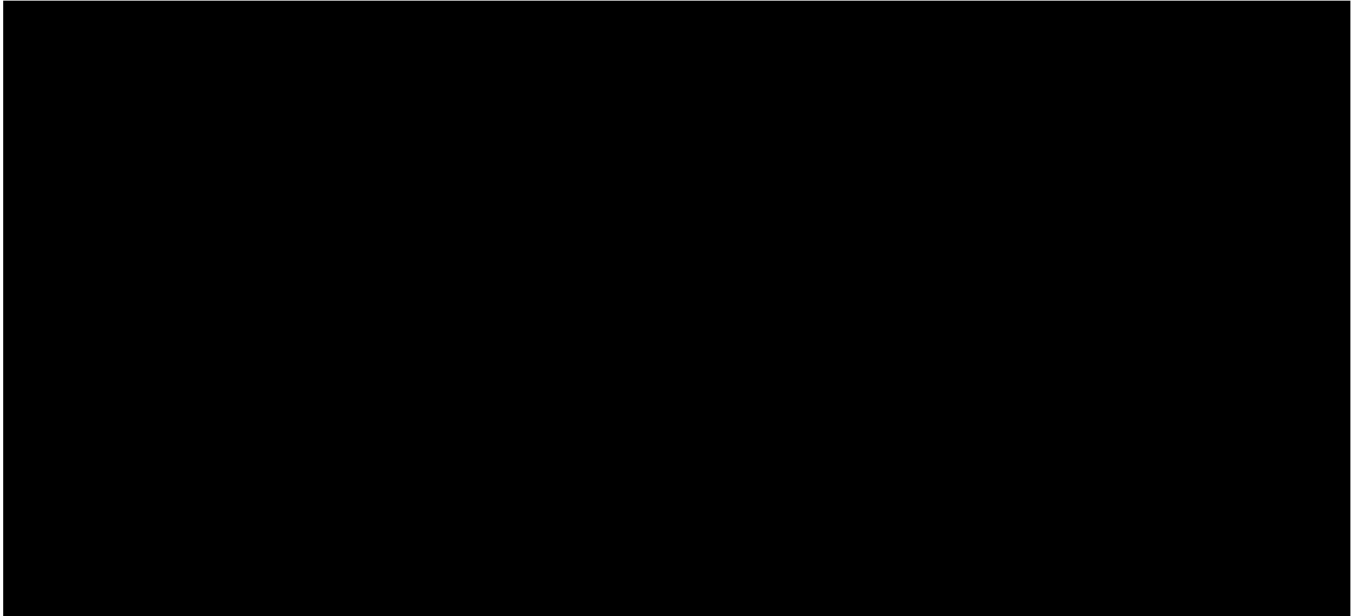

VOLUNTARY ASSIGNMENT AGREEMENT AND UNDERTAKING

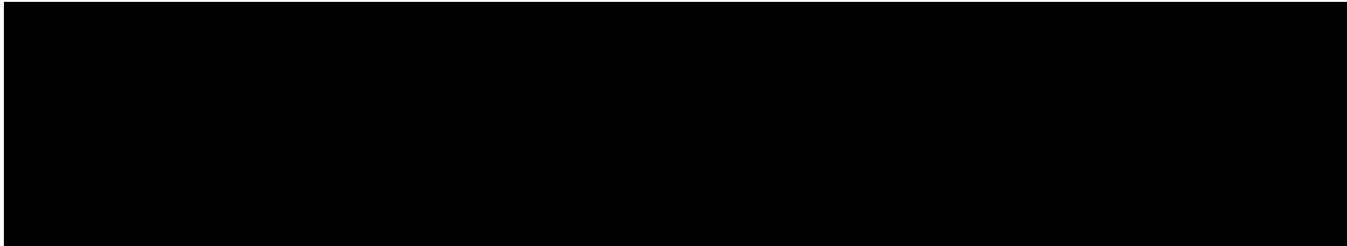

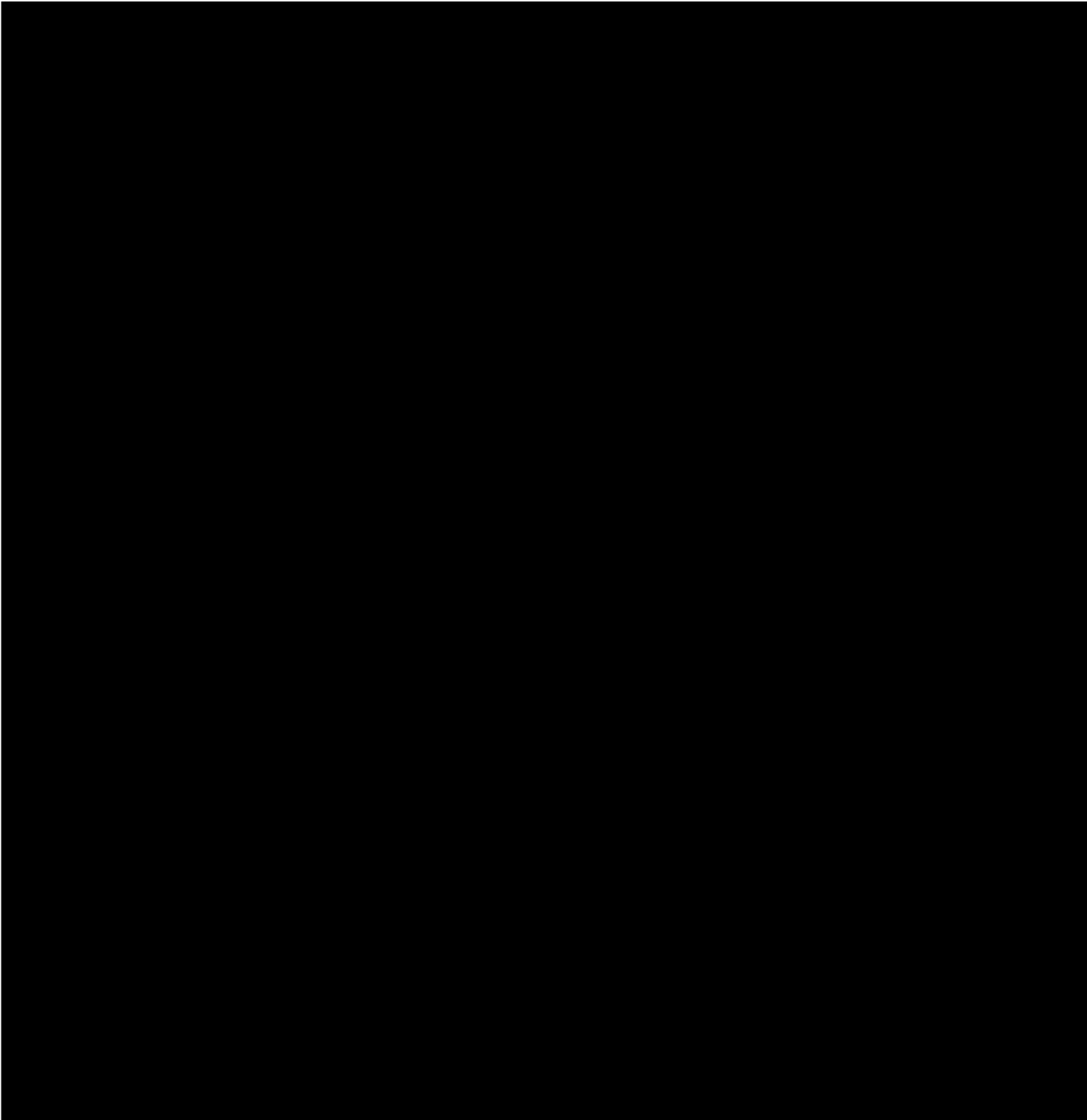

2. Acceptance. Assignee here accepts title to the Assigned Assets.






