**CONFIRMATORY ASSIGNMENT OF TRADEMARK RIGHTS –
USA**

PARTIES

Trussardi S p A , an Italian company of Piazza della Scala 5, 20121 Milano (MI) Italy
(Assignor)

Greyhound Beauty S.r.l., an Italian company of Via Melchiorre Gioia 8, 20124 Milano,
Italy (Assignee)

INTRODUCTION

- A The Assignor is the owner of the Trade Marks recited in the Trade Mark registrations set out in the Schedule (**Trade Marks**), including the goodwill associated with said Trade Marks
- B. The Assignor assigned to the Assignee all of the Assignor's rights, title and interest in and to the Trade Marks, including the goodwill associated therewith, solely insofar as goods in class 3 are concerned under an agreement **dated October 13, 2022 (Assignment Agreement)**.
- C. The Assignor has agreed to confirm such assignment under the Assignment Agreement, on the terms and conditions of this deed.

AGREEMENT

1. ASSIGNMENT

- 1.1 **Confirmation:** The Assignor hereby confirms the assignment by the Assignor to the Assignee of all the Assignor's rights, title and interest in and to the Trade Marks, including the goodwill associated therewith, solely insofar as goods in class 3 are concerned under the Assignment Agreement.
- 1.2 **Assignment:** In consideration of the sum of €1.00 paid by the Assignee to the Assignor and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged by the Assignor, the Assignor assigned to the Assignee absolutely all such rights, title and interest in and to the Trade Marks, including the goodwill associated therewith, solely in relation to goods in class 3. The full list of the assigned goods is set out in the Schedule
- 1.3 **Rights of action:** The assignment confirmed and effected by clauses 1.1 and 1.2 include, without limitation, the assignment and transfer of all rights of action, powers and benefits arising from the ownership of the Trade Marks including, without limitation, the right to sue for damages and other legal and equitable remedies in respect of all causes of action arising before, on or after the date of this deed.


2. GENERAL

- 2.1 **Further assurances:** The Assignor agrees to do all things and execute any further documents that may be required to give effect to the assignment confirmed and effected in this deed.

- 2.2 **Waiver:** No failure or delay by any party in exercising any right, power or privilege under this deed will operate as a waiver of such right, power or privilege, nor will any single or partial exercise preclude any other or further exercise of any right, power or privilege under this deed
- 2.3 **Governing law:** The formation, validity, construction and performance of this deed will be governed by and construed in accordance with the laws of the USA. The parties irrevocably agree that the courts of the USA will have non-exclusive jurisdiction to hear and determine all disputes under or in connection with this deed.
