TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of May 15, 2023, is made by Delaware Trust Company, in its capacity as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of QSL OPERATING LLC (the "Pledgor"). Capitalized terms used but not defined herein shall have the meanings set forth in the Trademark Security Agreement, whether defined directly therein or by reference to another agreement.

WITNESSETH:

WHEREAS, pursuant to that certain Security Agreement dated as of December 14, 2020, by and among TravelCenters of America Inc., as Borrower, each Subsidiary Loan Party party thereto and the Collateral Agent (as may have been amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement"), the Pledgor executed and delivered a Notice of Grant of Security Interest in Trademarks, dated December 14, 2020 (the "Trademark Security Agreement"), which was recorded in the United States Patent and Trademark Office on December 14, 2020 at Reel 7133, Frame 0391;

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Pledgor pledged and collaterally assigned to the Collateral Agent for the benefit of the Secured Parties, a continuing security interest (the "Security Interest") in all of such Pledgor's right, title and interest in, to and under the Trademark Collateral; including the Trademarks listed in **Schedule A** hereto; and

WHEREAS, the Collateral Agent now desires to terminate the Trademark Security Agreement and terminate and release the Security Interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (i) terminates the Trademark Security Agreement, (ii) terminates, cancels, releases, relinquishes and discharges the Security Interest in the Trademark Collateral, and (iii) reassigns to the Pledgor any right, title or interest, if any, the Collateral Agent may have in the Trademark Collateral of such Pledgor, in each case without recourse to the Collateral Agent, and without representation or warranty of any kind by the Collateral Agent. The Pledgor, and any successor to such Pledgor (including any person or entity hereafter holding any right, title or interest in and to the Trademark Collateral of such Pledgor or any designee of such Pledgor) is hereby authorized to record this Release with the United States Patent and Trademark Office.
