**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY COLLATERAL**

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this “Release”), having an effective date of December 30, 2022, is made by Cadence Bank, a Mississippi banking corporation (“Cadence”), in favor of Motor City Fastener, LLC, a Delaware limited liability company, Motor City Fastener Investments, LLC, a Delaware limited liability company, and Smith Fastener Acquisition, LLC, a Delaware limited liability company (collectively, “Owner”).

WHEREAS, Owner owns the trademarks set forth in Exhibit A (the “IP Collateral”);

WHEREAS, Owner and Cadence entered into a certain Security Agreement dated as of December 28, 2018 (as the same may be amended, restated, modified or supplemented from time to time, the “Security Agreement”; capitalized terms used herein but not otherwise defined herein shall have the meanings ascribed to them in the Security Agreement), pursuant to which Owner granted to Cadence a security interest in all of its personal property and assets, including, without limitation, the assets listed on Exhibit A attached hereto, as collateral to secure the Secured Obligations;

WHEREAS, Owner and Cadence entered into that certain Intellectual Property Security Agreement dated as of December 28, 2018, recorded at the United States Patent and Trademark Office (“USPTO”) on January 7, 2019, at Reel/Frame No. 6531/0346 in the USPTO Trademark Assignment Records database (“IP Security Agreement”), pursuant to which Owner granted to Cadence a security interest in the IP Collateral, including but not limited to the trademarks set forth in Exhibit A; and


WHEREAS, the Secured Obligations under the Security Agreement have been met and Cadence now desires to release its security interests in the IP Collateral and terminate the IP Security Agreement.

NOW THEREFORE, Cadence (on behalf of itself, its successors and assigns) hereby fully and irrevocably **RELEASES** and terminates, without representation, recourse or warranty whatsoever, the IP Security Agreement and all of its security interests in the IP Collateral, including without limitation the security interests granted under the Security Agreement, IP Security Agreement and any other agreement or document delivered in connection with the foregoing, and Cadence hereby reassigns any and all such right, title and interest (if any) that Cadence or any of its successors and assigns may have in the IP Collateral to the Owner or to the owner that is the record owner of the IP Collateral, as applicable.
