**INTELLECTUAL PROPERTY RIGHTS ASSIGNMENT**

This Intellectual Property Rights Assignment (this “Assignment”) is made effective this 1st day of May, 2023, by and among the Persons listed on the signature pages hereto (each individually, an “Assignor” and collectively, the “Assignors”) and SunMed Group Holdings, LLC, a Delaware limited liability company (“Assignee”).

WHEREAS, Assignors possess certain rights in and to the trademarks and trademark applications (and trademarks issuing on such applications) set forth on Exhibit B attached hereto and incorporated herein by reference (the “Trademarks Rights”);

WHEREAS, Vyair Holding Company, a Delaware limited liability company (“Seller”) and Assignee are parties to that certain Stock and Asset Purchase Agreement, dated as of the 27<sup>th</sup> day of March, 2023 (the “Purchase Agreement”) (all capitalized terms used herein but not defined having the definitions ascribed therein), pursuant to which Seller agreed to cause certain of its Affiliates (including the Asset Seller Entities) to sell, assign, transfer and convey to Assignee certain of the assets of such entities, including the Patent Rights and Trademark Rights;

WHEREAS, Seller, Assignors and Assignee are party to that certain Assignment and Assumption Agreement and Bill of Sale, dated as of the 1st day of May 2023 (the “Bill of Sale”), pursuant to which the Assignors sold, assigned, transferred and conveyed to Assignee all of each Assignor’s right, title and interest in and to certain assets, including the Patent Rights and Trademark Rights; and

WHEREAS, the execution and delivery of the Bill of Sale is a condition to Closing under the Purchase Agreement, and the execution and delivery of this Assignment is for recordation purposes only.

NOW, THEREFORE, in consideration of the mutual covenants, terms and conditions set forth in the Purchase Agreement, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Each Assignor does hereby sell, assign, transfer and convey to Assignee all of such Assignor’s right, title and interest in and to the Patent Rights and the Trademark Rights (including any common law rights that may exist and are associated therewith), together with the goodwill of the business symbolized thereby and appurtenant thereto.
2. Section 4.4 (*Further Assurances*), Section 9.4 (*Counterparts*) and Section 9.5 (*Governing Law*) of the Purchase Agreement are incorporated by reference to this Assignment, *mutatis mutandis*.
3. This Assignment shall be without prejudice to the Purchase Agreement or the Bill of Sale. In the event of any conflict or inconsistency between the terms of this Assignment and the Purchase Agreement or the Bill of Sale, the terms of the Purchase Agreement or the Bill of Sale, as applicable, shall control.
4. Each Assignor hereby authorizes the Director of the United States Patent & Trademark Office, and the empowered officials of all other governments whose duty it is to record patents, trademarks, applications and title thereto, to record the Patent Rights, the Trademark Rights and title thereto on either of the foregoing as the property of Assignee,

its successors, assigns, or legal representatives in accordance with the terms of this instrument.
