TRADEMARK ASSIGNMENT

TRADEMARK ASSIGNMENT, dated as of April __, 2023 (this “Assignment”), by and between IMG Academy, LLC, a Florida limited liability company (“Assignor”), and IMG Worldwide, LLC, a Delaware limited liability company (“Assignee”).

WITNESSETH:

A. Assignor is a controlled, indirect subsidiary of Assignee.

B. The parties wish to execute this Assignment for purposes of transferring the trademarks and filing this Assignment with the United States Patent and Trademark Office and all applicable foreign intellectual property offices, as may be necessary to effectuate the assignment and transfer of the trademarks to the Assignee.

NOW, THEREFORE, in consideration of the mutual promises made herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and upon the terms and subject to the conditions set forth herein, the parties hereto hereby agree as follows:

1. Assignor hereby assigns, transfers and delivers to Assignee (a) all of its rights, title and interest in and to all trademarks, service marks and trade names (whether registered or unregistered) owned by Assignor as of the date hereof that incorporate or contain “IMG” or the IMG marks, including, without limitation, the trademarks listed on Schedule I (the “Marks”), (b) the goodwill of the business symbolized by and associated with the Marks, (c) all applications and registrations thereof throughout the world, and (d) the right to sue and recover for, and the right to the profits or damages due or accrued arising out of or in connection with, any and all past, present or future infringement, passing off or dilution of, or damage or injury to the Marks.
2. Assignor hereby acknowledges and agrees that from and after the date hereof, Assignee shall be the exclusive owner of all of the Marks.
3. Assignor shall take such actions and execute and deliver to Assignee such further deeds, bills of sale, assignments or other transfer documents as Assignee may reasonably request to effectively assign, transfer and convey, and to evidence such assignment, transfer and conveyance of, the Marks to Assignee, in each case, at the sole cost and expense of Assignor.
4. Assignor hereby authorizes and requests the appropriate empowered officials at the United States Patent and Trademark Office and equivalent offices in foreign jurisdictions to record Assignee as the owner of all registrations and pending applications for the Marks to Assignee and to issue any and all Marks to Assignee as owner of the entire right, title and interest therein or otherwise as Assignee may direct, in accordance with this instrument of assignment.
5. The parties agree that (i) the assignment and transfer of the Marks from Assignor to Assignee shall be treated for applicable tax purposes as a distribution of the Marks from Assignor to its sole owner IMG Academy Parent, LLC, followed by a distribution of the

Marks from IMG Academy Parent, LLC to Assignee and (ii) notwithstanding the foregoing, from and after the date hereof, IMG Academy Parent, LLC shall retain (and shall not distribute) certain license rights to use, reproduce, display, and otherwise exploit the Marks in a manner consistent with the license rights set forth in that certain trademark license agreement shared between IMG Academy Parent, LLC and Assignee (and, for the avoidance of doubt, upon the effectiveness of any license agreement by such parties such license agreement shall solely control and govern the rights of the parties thereto with respect to the Marks).

6. This Assignment shall be construed in accordance with, and governed by, the laws of the State of Delaware, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of Delaware or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the State of Delaware. Each party hereto consents to personal jurisdiction and proper venue in any state or federal court having jurisdiction in the State of Delaware and waives and relinquishes all right to attack the suitability or convenience of such venue or forum by reason of their present or future domiciles, or by any other reason.
7. This Assignment may be executed in one or more counterparts, each of which shall be deemed an original but all of which together will constitute one and the same instrument. This Assignment or any counterpart may be executed and delivered by facsimile copies or delivered by electronic communications, including by portable document format (.pdf), each of which shall be deemed an original


