RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of June 7, 2023, by First Horizon Bank, as Administrative Agent (“Lender”) in favor of Medliminal, LLC, a Delaware limited liability company (“Borrower”).

WITNESSETH:

WHEREAS, pursuant to that certain Trademark Security Agreement dated February 4, 2022, by and among Borrower and Lender (the “Security Agreement”), recorded on February 4, 2022, at Reel No. 7622, Frame 0774, United States Patent and Trademark Office, Borrower granted a security interest in certain trademarks in favor of Lender to secure certain debt owing from Borrower to Lender;

WHEREAS, Borrower has requested that Lender (i) terminate and release the liens and interests of Lender in certain of Borrower’s trademarks as set forth in **Exhibit A** attached hereto (collectively, the “Trademarks”), and (ii) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office and other appropriate offices; and


WHEREAS, Lender has agreed to such release and termination.
