**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made as of June 7, 2023, by First Horizon Bank, as Administrative Agent (“Lender”) in favor of EIR CL MIDCO, LLC, a Delaware limited liability company, and ARC HEALTHCARE TECHNOLOGIES LLC, a Georgia limited liability company (collectively, “Grantors”).

**WITNESSETH:**

WHEREAS, pursuant to that certain Trademark Security Agreement dated December 29, 2021, by and among Grantors and Lender (the “Security Agreement”), recorded on December 15, 2021, at Reel No. 7531, Frame 0695, United States Patent and Trademark Office, Grantors granted a security interest in certain trademarks in favor of Lender to secure certain debt owing from Grantors to Lender;

WHEREAS, Grantors have requested that Lender (i) terminate and release the liens and interests of Lender in certain of Grantor’s trademarks as set forth in **Exhibit A** attached hereto (collectively, the “Trademarks”), and (ii) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office and other appropriate offices; and

WHEREAS, Lender has agreed to such release and termination.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Lender hereby releases and terminates its security interests in the Trademarks, and reassigns to Grantors all right, title and interest of Lender in and to the Trademarks.
