NOTICE OF RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY

This NOTICE OF RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY ("Notice of Release"), dated as of June 9, 2023 ("Effective Date"), is made by eCapital Asset Based Lending Corp. (formerly known as Gerber Finance Inc.), a New York corporation ("Lender"), in favor of Cook San Francisco LLC, a Delaware limited liability company ("Grantor").
