TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is granted and made as of June 9, 2023, and made by **CITIZENS BANK, N.A.**, as administrative agent and collateral agent (the "Grantee"), to **ONEONCOLOGY, LLC.**, a Delaware limited liability company (the "Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of January 7, 2022 by the Grantor in favor of the Grantee (the "Security Agreement"), a security interest was granted by the Grantor to the Grantee in the Intellectual Property Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded at the United States Patent and Trademark Office on March 11, 2022 at Reel/Frame 7656/0985; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property Collateral" as used herein, shall have the meaning set forth in the Security Agreement, and includes all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule 1 hereto.

2. Release of Security Interest. Grantee hereby irrevocably terminates the Security Agreement and automatically and irrevocably terminates, releases and discharges any and all liens on and security interest in and any and all rights, titles and interests that Grantee may have obtained in the Intellectual Property Collateral and reassigns, grants and conveys to Grantor all right, title and interest of Grantee in the Intellectual Property Collateral, including all goodwill associated therewith. Grantee hereby irrevocably waives and relinquishes all of Grantee's rights, powers, privileges and remedies under the Security Agreement solely with respect to the Grantee and its successors and permitted assigns for all covenants, obligations, liabilities, and warranties of the Grantor under the Security Agreement. Grantee authorizes the recordation of this Termination with the United States Patent and Trademark Office.


