**Partial Release of Security Interest in Trademarks**

This Partial Release of Security Interest in Trademarks, dated as of May 31, 2023 (this "Partial Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (in such capacity, the "Agent") in favor of SIMPSON PERFORMANCE PRODUCTS, INC. (the "Grantor").

WHEREAS, by (i) that certain Security Agreement, dated as of November 18, 2021 in favor of Agent, as supplemented by that certain Security Agreement Supplement, dated as of May 27, 2022 (as the same may be further amended, restated, supplemented or modified from time to time, the "Security Agreement") and (ii) that certain related Trademark Security Agreement, dated as of November 18, 2021 in favor of Agent (the "Original Trademark Security Agreement"), as supplemented by that certain Security Agreement Supplement for Trademarks, dated as of May 27, 2022 (the "Trademark Supplement", and together with the Original Trademark Security Agreement, and as the same may be further amended, restated, supplemented or modified from time to time, the "Trademark Security Agreement"; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), the Grantor granted to Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor's right, title and interest in, to and under the Collateral (as defined in the Trademark Security Agreement), including that Trademark listed on Schedule I hereto;

WHEREAS, the Original Trademark Security Agreement was recorded with the United States Patent and Trademark Office on November 19, 2021 at Reel 7500 and Frame 0557;

WHEREAS, the Trademark Supplement was recorded with the United States Patent and Trademark Office on May 27, 2022 at Reel 7734 and Frame 0678;

WHEREAS, the Trademark of the Grantor listed on Schedule I hereto (the "Released Trademark Collateral") was included in the Trademark Collateral;

WHEREAS, the Grantor has notified the Agent that the Released Trademark Collateral has been sold and has requested, and the Agent has agreed, to provide this Partial Release in order to terminate and release the Agent's security interest solely with respect to the Released Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Released Trademark Collateral of the Grantor, including any and all goodwill relating to the same, and assigns, transfers and conveys to Grantor any and all of its rights, title and interests in the Released Trademark Collateral.

This Partial Release is applicable only and solely with respect to the Released Trademark Collateral and to no other collateral arising under the Security Agreement or the Trademark Security Agreement. The Agent retains all security interests, liens, rights, title and interests pledged and granted to the Agent under the Security Agreement and the Trademark Security Agreement with respect to all such other collateral, and the Agent's security interest, liens, rights,

titles and interests in such other collateral shall not, and shall not be deemed to, be impaired, interrupted or otherwise modified in any respect by this Partial Release.

The Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Partial Release.

This Partial Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
