

Pursuant to applicable provisions of the Washington Business Corporation Act, Revised Code of Washington ("RCW") § 23B.11, *et seq.*, as amended (the "Washington Act"), and the Colorado Corporations and Associations Act, Colorado Revised Statutes ("C.R.S.") § 7-90-201, *et seq.*, as amended (the "Colorado Act"), Columbia Bean and Produce Company, Incorporated, a Washington corporation (the "Merging Entity") and Trinidad/Benham Corp., a Colorado corporation (the "Surviving Entity") do hereby submit the following Articles of Merger.


1. Effective Date. The merger shall become effective upon December 31, 2022.
2. Merger of Merging Entity With and Into Surviving Entity. Upon the Effective Date, the Merging Entity shall merge with and into the Surviving Entity (which is the sole shareholder of the Merging Entity). The Merging Entity will cease to exist, and all of the assets will be vested in, and all of its liabilities assumed by the Surviving Entity.
3. Effect of Merger on Capital Stock of Merging Entity. Upon the Effective Date, each share of common stock of the Merging Entity issued and outstanding on the date of merger shall be cancelled.
4. Merger Approval by the Merging Entity. The merger was duly approved by the Board of Directors of the Merging Entity pursuant to RCW § 23B.11.030 and RCW § 23B.11.040 of the Washington Act.
5. Merger Approval by the Surviving Entity. The merger was duly approved by the Board of Directors of the Surviving Entity pursuant to C.R.S § 7-90-203.4 of the Colorado Act.
6. The Certificate of Incorporation and the Bylaws of the Surviving Entity shall continue in full force and effect.
