## TRADEMARK ASSIGNMENT

This Trademark Assignment, effective *nunc pro tunc* as of September 1, 2022 (the "Effective Date"), is made by and between Cortland Company, Inc., a corporation organized and existing under the laws of the State of Delaware, U.S.A. with its headquarters located at 10633 West Airport Blvd., Ste. 300, Stafford, TX 77477 ("Assignor"), and Cortland Industrial LLC, a limited liability company organized and existing under the laws of the State of Delaware, U.S.A., with its headquarters located at N86 W12500 Westbrook Crossing, Menomonee Falls, WI 53051 ("Assignee").

WHEREAS, Assignor and Assignee have entered into that certain Subscription and Contribution Agreement effective as of the Effective Date (the "Subscription and Contribution Agreement");

WHEREAS, under the terms of the Subscription and Contribution Agreement, Assignor has conveyed, assigned, transferred, and delivered to Assignee, all of Assignor's right, title, and interest in and to the Contributed Assets and Liabilities (as defined in the Subscription and Contribution Agreement) which include, *inter alia*, the trademark registrations identified in the Trademark Schedule attached hereto (the "Trademarks"); and

WHEREAS, Assignor has agreed to execute and deliver this Trademark Assignment to Assignee pursuant to the Subscription and Contribution Agreement.

NOW, THEREFORE, for one dollar (\$1.00) and in consideration of the mutual promises, conditions, and covenants set forth in the Subscription and Contribution Agreement, and for other good and valuable consideration, the receipt of which is hereby acknowledged, the parties hereby agree as follows:

1. Assignor hereby irrevocably conveys, transfers and assigns unto Assignee, and Assignee hereby accepts all of Assignor's right, title and interest in and to the Trademarks, including, without limitation, all issuances, extensions, and renewals thereof, together with the goodwill of the business symbolized by said Trademarks; all of Assignor's common law trademark rights in the Trademarks; and the rights to sue for past, present and future infringements, dilution, misappropriation, violation, misuse, breach, or default with respect to any of the foregoing, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Assignor and Assignee consent to the recordal of this Trademark Assignment.

3. The parties acknowledge and agree that this Trademark Assignment is entered into pursuant to the Subscription and Contribution Agreement, to which reference is made for a further statement of the rights and obligations of Assignor and Assignee with respect to the Trademarks. In the event of any conflict or inconsistency between the terms of the Subscription and Contribution Agreement and the terms hereof, the terms of the Subscription and Contribution Agreement shall govern.

4. This Trademark Assignment inures to the benefit of the Assignee and its successors, assigns, and other legal representatives, and is binding on Assignor and its respective successors, assigns, and other legal representatives.

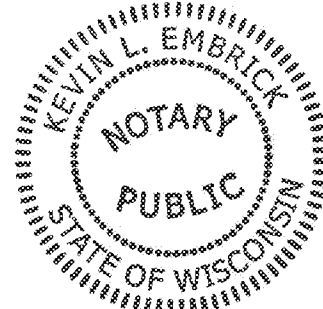
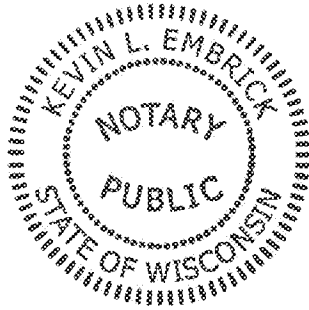
