**PARTIAL TERMINATION AND RELEASE OF  
FIRST LIEN SECURITY INTEREST IN TRADEMARKS**

This Partial Termination and Release of First Lien Security Interest in Trademarks (“Trademark Release”) is made as of June 9, 2023, by **MACQUARIE CAPITAL FUNDING LLC**, a Delaware limited liability company (in such capacity, together with its successors and assigns in such capacity, “Collateral Agent”), in favor of **MEDIAOCEAN LLC**, a Delaware limited liability company with an address at 45 West 18<sup>th</sup> Street, New York, New York 10011 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into that certain Trademark Security Agreement, dated December 15, 2021 (the “Trademark Security Agreement”), with Collateral Agent, notice of which was recorded on December 22, 2021 at the United States Patent and Trademark Office at Reel 7539, Frame 0379.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of such Grantor’s Trademark Collateral, including without limitation the Trademarks listed in Schedule A hereto.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest solely in the Trademark Collateral set forth in Schedule A as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby agrees that:

1. The Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral of the Grantor set forth on Schedule A, and assigns, transfers and conveys to Grantor such interest in the Trademark Collateral.


2. The Collateral Agent authorizes and requests that the United States Patent and Trademark Office and any other applicable government office record this Trademark Release.

3. THIS TRADEMARK RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TRADEMARK RELEASE SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK (EXCEPT FOR CONFLICTS OF LAW PRINCIPLES THAT WOULD RESULT IN THE APPLICATION OF THE LAWS OF ANOTHER JURISDICTION).


