## RELEASE OF INTELLECTUAL PROPERTY SECURITY INTERESTS

WHEREAS, the undersigned, BANKUNITED, N.A. has hitherto entered into security agreements with NATIONAL ENTERTAINMENT NETWORK, LLC and FOLZ VENDING, LLC ("Grantors"), whereby Grantors granted security interests in certain of its intellectual property to the undersigned, to wit: a PATENT, COPYRIGHT AND TRADEMARK SECURITY AGREEMENT dated as of June 1, 2018 (the "IP Agreement"); and

WHEREAS, the undersigned wishes to release and reassign any and all right, title and interest in the collateral covered by the IP Agreement which was recorded with the United States Patent and Trademark Office on June 22, 2018 in its records at Reel 006361, Frame 0224 (collectively, the "Intellectual Property Collateral").

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the undersigned agrees:

1. Intellectual Property Collateral includes, without limitation, all of the undersigned's right, title and interest of every kind and nature as of the date hereof in any and all of each Grantor's:
  - (a) registered or unregistered trademarks, service marks, trade and brand names, logos, trade dress, design rights, and other comparable designations of source, sponsorship, association or origin, including the trademark registrations and applications listed in Schedule A hereto, along with the goodwill associated with the use thereof and symbolized thereby, and all renewals and extensions thereof;
  - (b) registered or unregistered copyrights, copyright applications and registrations, comparable protections in works of authorship, whether published or unpublished, and mask works, including the copyright registrations and applications set forth in Schedule B hereto;
  - (c) leased or owned domain names set forth in Schedule C hereto;
  - (d) licenses and other agreements pursuant to which any Grantor is granted, or grants, a license or other right, whether exclusive or non-exclusive, to (i) use or develop the foregoing, (ii) receive royalties, income, or other payments or compensation with respect thereto, or (iii) exercise any other rights with respect thereto, and any and all amounts now or hereafter due or payable with respect to the foregoing; and
  - (e) legal or equitable claims or causes of action (including for infringement) with respect to the foregoing, whensoever having occurred or occurring.
2. The undersigned, for itself and its successors, representatives, agents, and assigns, hereby terminates, releases and discharges its security interests in and to the Intellectual Property Collateral, and any other rights or interests it may have with respect thereto, and reassigns to Grantor any and all such rights and interests. The undersigned agrees to execute and deliver such further instruments and take or cause to be taken other or further action as each Grantor may reasonably request in order to perfect, confirm, or evidence such release.

3. This release shall be governed by, and construed in accordance with, the laws of the State of New York.
