TERMINATION AND RELEASE OF SECURITY INTEREST

THIS TERMINATION AND RELEASE OF SECURITY INTEREST is made as of June 13, 2023, by TWIN BROOK CAPITAL PARTNERS, LLC (“Secured Party”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

WITNESSETH:

WHEREAS, ClaimLogiq LLC, a Georgia limited liability company (f/k/a ARC Healthcare Technologies LLC, a Georgia limited liability company) and Medliminal, LLC, a Delaware limited liability company (each an “Assignor” and together “Assignors”) and Secured Party were parties to that certain Trademark Security Agreement dated as of June 22, 2022 (the “Security Agreement”) pursuant to which each Assignor granted a security interest to Secured Party in certain trademarks and service marks set forth on Schedule 1A annexed hereto (the “Trademarks”) and Trademark Collateral (as defined below) as security for certain obligations owing by Assignors to Secured Party;

WHEREAS, the Security Agreement was recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office on June 22, 2022, at Reel 7782, Frame 0159;

WHEREAS, Assignors have requested that Secured Party terminate and release its security interest in the Trademarks and Trademark Collateral and any and all rights in the same;

WHEREAS, Assignors have satisfied and fulfilled all of its obligations to release the Secured Party’s security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Secured Party hereby terminates and releases its security interest in all of each Assignor’s right, title and interest in, to, and under the Collateral, including the following (collectively the “Trademark Collateral”):

(a) each Trademark listed on Schedule 1A annexed hereto, together with any applications and registrations thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(b) all products and proceeds of the foregoing, including without limitation, any and all damages, causes of action or claims which may exist for past, present or future (i) infringement or dilution of each such Trademark, and (ii) injury to the goodwill associated with each such Trademark.

2. The parties hereto acknowledge that this document may be filed along with any other necessary documentation with the United States Patent and Trademark Office or any other domestic or foreign governmental office to evidence the release granted herein. Secured Party will execute such further documents as deemed reasonably necessary by each Assignor to confirm and effect this release.
