CONFIRMATION OF TRADEMARK ASSIGNMENT

This Confirmation of Trademark Assignment ("**Assignment**") is entered into by and between Viptela LLC, a Delaware Limited Liability Company ("**Viptela**") and Cisco Systems, Inc., a Delaware corporation ("**CSI**"), as successor in interest to Cisco Systems, Inc., a California corporation ("**Cisco**").

NOW, THEREFORE, Viptela and CSI confirm that:

"Viptela Marks" means all of Viptela's trademarks, service marks, trade names, trade dress, logos, designs and slogans, in word mark, stylized and/or design formats, including without limitation Viptela's trademark registrations and applications and any and all of Viptela's common law rights in the aforementioned items, together with all goodwill associated with and symbolized by the aforementioned items, including without limitation the marks identified in Schedule 1 attached hereto and all of the goodwill associated with and symbolized by such marks.

Effective August 2, 2017, Viptela has assigned and transferred, and Cisco received and accepted, all of Viptela's rights, title and interest throughout the world in and to the Viptela Marks and all the rights, claims and privileges pertaining to the Viptela Marks, including without limitation: the registrations and applications pertaining thereto, together with all of the goodwill of the business associated with and symbolized by the Viptela Marks; and the right to sue and recover damages for past, present and future infringements thereof and to stand in the place of Viptela in all matters related thereto.

Viptela hereby authorizes and requests the United States Commissioner of Patents and Trademarks to implement this Assignment.
