**TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this "Termination and Release"), is dated as of June 14, 2023, and made by **PNC BANK, NATIONAL ASSOCIATION**, as successor in interest to BBVA USA (f/k/a Compass Bank (d/b/a BBVA Compass)), in its capacity as Administrative Agent (the "Grantee"), to **DATA CENTRUM COMMUNICATIONS, INC.**, a Delaware corporation (the "Grantor"). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement (as defined below).

**WHEREAS**, pursuant to the terms and conditions of that certain Trademark Security Agreement, dated as of May 15, 2019, made by the Grantor in favor of the Grantee (the "Trademark Security Agreement"), a continuing security interest (the "Security Interest") in all right, title and interest of the Grantor in, to and under the Collateral (including for the avoidance of doubt those trademarks and trademark applications set forth on Exhibit A hereto), to secure the payment, performance and observance of the Secured Obligations (as defined in the Guarantee and Collateral Agreement) was granted by the Grantor to the Grantee for the benefit of the Lender;

**WHEREAS**, the Trademark Security Agreement was recorded with trademark division of the United States Patent and Trademark Office on May 15, 2019, at Reel/Frame 6646/0618;

**WHEREAS**, Grantee now desires to terminate the Trademark Security Agreement and terminate, release and discharge its Security Interest in the Collateral (including for the avoidance of doubt those trademarks and trademark applications set forth on Exhibit A hereto);


**NOW, THEREFORE**, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, Grantee hereby states as follows:

Grantee, on behalf of itself and the Secured Parties (as defined in the Guarantee and Collateral Agreement), hereby terminates the Trademark Security Agreement and terminates, releases and forever discharges the Security Interest in the Collateral (including for the avoidance of doubt those trademarks and trademark applications set forth on Exhibit A hereto), and retransfers and reassigns to the Grantor, without representation, warranty or recourse of any kind, express or implied, free and clear of any claims by Grantee, all right, title or interest of the Grantee in, to or under the Collateral (including for the avoidance of doubt those trademarks and trademark applications set forth on Exhibit A hereto).
