TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT (this “Assignment”) is entered into and effective as of this 14th day of May, 2021 (the “Effective Date”), by (i) **ADDCAR SYSTEMS, LLC F/K/A UGM ADDCAR SYSTEMS, LLC F/K/A ICG ADDCAR SYSTEMS, LLC**, a Delaware limited liability company (“Assignor”), in favor of (ii) **EAGLE HIGHWALL MINING SYSTEMS, LLC**, a Delaware limited liability company (“Assignee”) (each of Assignor and Assignee, a “Party,” and together, the “Parties”).

RECITALS

A. Assignor owns the trademark and service mark “ADDCAR” (the “Mark”) used in connection with certain products and services sold and rendered in relation to the highwall mining of coal.

B. Assignor also owns certain federal and foreign trademark registrations for the Mark, as more fully described on Exhibit A, attached hereto and incorporated herein (the “Registrations”).

C. Pursuant to that certain Asset Purchase Agreement dated the Effective Date among Assignor, Assignee and Eagle Pike Properties, LLC, a Kentucky limited liability company (the “Purchase Agreement”), Assignee is purchasing and acquiring from Assignor, and Assignor is transferring and selling to Assignee, certain tangible and intangible assets of Assignor, including the Marks and the Registrations, all on the terms and conditions set forth in the Purchase Agreement

D. In accordance with the Purchase Agreement, Assignor desires to assign the Mark, including the Registrations, together with all the goodwill associated with and symbolized by the Mark, to Assignee, and Assignee desires to obtain the same from Assignor, on the terms and conditions set forth herein.

ASSIGNMENT

NOW, THEREFORE, the Parties agree as follows:

1. ASSIGNMENT. Assignor hereby transfers and assigns to Assignee, free and clear of Encumbrances, the Mark and the entire and exclusive right, title, and interest in and to the Mark within North America, South America, Central America and the Caribbean (the “Buyer Territory”), including, without limitation, the Registrations, and all issuances, extensions, and renewals thereof, together with all of the goodwill associated with and symbolized by the Mark within the Buyer Territory, and Assignee accepts all the foregoing from Assignor.

2. FURTHER ASSURANCES. Upon Assignee’s reasonable request, Assignor shall, without need for further consideration, cooperate with Assignee to ensure that Assignor’s performance under this Assignment is fully discharged, including, without limitation, by executing and delivering such other documents and taking such other actions as may be necessary to consummate and effectuate the transfer and assignment of the Mark and the Registrations to Assignee.

3. COUNTERPARTS. This Assignment may be executed in counterparts, each of which will be deemed an original, with the same effect as if the signature on each such counterpart were on the same instrument. Further, this Assignment may be executed by transfer of an originally signed document by facsimile, electronic or e-mail in PDF format, each of which will be as fully binding as an original document.

4. PURCHASE AGREEMENT. This Assignment is made subject to and pursuant to the Purchase Agreement, and all of the terms, agreements and indemnities set forth in the Purchase Agreement are incorporated by reference herein and made a part hereof. This Assignment is subject in all respects to the provisions of the Purchase Agreement and is not meant to alter, enlarge, or otherwise modify the provisions of the Purchase Agreement. In the event of any conflict between the terms of the Purchase Agreement and this Assignment, the terms of this Assignment shall prevail and control in the interpretation, operation and effect thereof. The Purchase Agreement shall remain in full force and effect and is expressly ratified and confirmed by the Parties.
