## TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT dated as of May 12, 2023 (this "Agreement"), among At Home Stores LLC (the "Grantor") and Delaware Trust Company ("Delaware Trust") in its capacity as Intercompany Note Collateral Agent for the Secured Parties party to the Intercompany Note referred to below (in such capacity, the "Intercompany Note Collateral Agent").

WHEREAS, reference is made to (a) the Intercompany Note, dated as May 12, 2023 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Intercompany Note"), by and among At Home Group Inc., a corporation organized under the laws of the State of Delaware (the "Company"), the other Grantors party thereto, At Home Cayman, an exempted company with limited liability organized under the laws of the Cayman Islands (the "Holder"), and Delaware Trust, as the Administrative Agent and as Intercompany Note Collateral Agent and (b) the Intercompany Note Pledge and Security Agreement, dated as of May 12, 2023 (the "Security Agreement"), by and among the Company, Holdings, the Subsidiary Parties from time to time party thereto (the "Grantors"), the Additional Parties from time to time party thereto and the Intercompany Note Collateral Agent;

WHEREAS, the Grantor is willing to execute and deliver this Agreement as consideration for such extensions of credit.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

SECTION 1. Terms. Capitalized terms used in this Agreement and not otherwise defined herein have the meanings specified in the Security Agreement or the Intercompany Note, as applicable.

SECTION 2. Grant of Security Interest. As security for the payment or performance, as the case may be, in full of the Secured Obligations, the Grantor hereby grants to the Intercompany Note Collateral Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest (the "Security Interest") in all of such Grantor's right, title and interest in, to and under any Trademarks now owned or at any time hereafter acquired by such Grantor, including those listed on Schedule I (the "Collateral").

SECTION 3. Security Agreement. The Security Interest granted to the Intercompany Note Collateral Agent herein is granted in furtherance, and not in limitation, of the security interests granted to the Intercompany Note Collateral Agent pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Intercompany Note Collateral Agent with respect to the Collateral are more fully set forth in the Security Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the Security Agreement, the terms of the Security Agreement shall govern. In its execution of this Agreement, the Intercompany Note Collateral Agent shall be entitled to all of the rights, protections, immunities and indemnities afforded to it pursuant to the Intercompany Note and Security Agreement.

SECTION 4. Counterparts. This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original but all of which when taken together shall constitute a single contract. Delivery of an executed signature page to this Agreement by facsimile or other electronic transmission shall be effective as delivery of a manually signed counterpart of this Agreement.

SECTION 5. GOVERNING LAW. THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.


SECTION 6. *INTERCREDITOR AGREEMENT GOVERNS.* NOTWITHSTANDING ANYTHING HEREIN TO THE CONTRARY, THE LIENS AND SECURITY INTERESTS GRANTED TO THE INTERCOMPANY NOTE COLLATERAL AGENT FOR THE BENEFIT OF THE SECURED PARTIES PURSUANT TO THIS AGREEMENT AND THE EXERCISE OF ANY RIGHT OR REMEDY BY THE INTERCOMPANY NOTE COLLATERAL AGENT WITH RESPECT TO ANY COLLATERAL HEREUNDER ARE SUBJECT TO THE PROVISIONS OF ANY APPLICABLE INTERCREDITOR AGREEMENT. IN THE EVENT OF ANY CONFLICT BETWEEN THE PROVISIONS OF ANY APPLICABLE INTERCREDITOR AGREEMENT AND THIS AGREEMENT, THE PROVISIONS OF SUCH INTERCREDITOR AGREEMENT SHALL GOVERN AND CONTROL. SO LONG AS THE EQUAL PRIORITY INTERCREDITOR AGREEMENT IS OUTSTANDING, THE REQUIREMENT OF THIS AGREEMENT OR ANY OTHER INTERCOMPANY NOTE DOCUMENT TO DELIVER COLLATERAL TO THE INTERCOMPANY NOTE COLLATERAL AGENT (OR ANY REPRESENTATION OR WARRANTY HAVING THE EFFECT OF REQUIRING THE SAME) SHALL BE DEEMED SATISFIED (OR ANY SUCH REPRESENTATION OR WARRANTY SHALL BE DEEMED TRUE BY DELIVERY OF SUCH COLLATERAL TO THE CONTROLLING COLLATERAL AGENT AS BAILEE OF, AND ON BEHALF OF, THE INTERCOMPANY NOTE COLLATERAL AGENT PURSUANT TO THE EQUAL PRIORITY INTERCREDITOR AGREEMENT). SO LONG AS THE ABL/FIXED ASSET INTERCREDITOR AGREEMENT IS OUTSTANDING, THE REQUIREMENT OF THIS AGREEMENT OR ANY OTHER INTERCOMPANY NOTE DOCUMENT TO DELIVER ABL PRIORITY COLLATERAL TO THE INTERCOMPANY NOTE COLLATERAL AGENT (OR ANY REPRESENTATION OR WARRANTY HAVING THE EFFECT OF REQUIRING THE SAME) SHALL BE DEEMED SATISFIED (OR ANY SUCH REPRESENTATION OR WARRANTY SHALL BE DEEMED TRUE BY DELIVERY OF SUCH COLLATERAL TO THE ABL FACILITY AGENT (AS SUCH TERM IS DEFINED IN THE ABL/FIXED ASSET INTERCREDITOR AGREEMENT) AS BAILEE OF, AND ON BEHALF OF, THE INTERCOMPANY NOTE COLLATERAL AGENT PURSUANT TO THE ABL/FIXED ASSET INTERCREDITOR AGREEMENT).

SECTION 7. Concerning the Intercompany Note Collateral Agent. Delaware Trust is entering into this Agreement solely in its capacity as Intercompany Note Collateral Agent under the Intercompany Note and shall be entitled to all of the rights, privileges and immunities granted to the Intercompany Note Collateral Agent under the Intercompany Note as if such rights, privileges and immunities were set forth herein.
