TRADEMARK ASSIGNMENT

This assignment is made as of the last date of execution below (the “Effective Date”), by and between Invitation Homes L.P., a limited partnership organized under the laws of the State of Delaware (“**Assignor**”), and Invitation Homes Operating Partnership LP, a limited partnership organized under the laws of the State of Delaware (“**Assignee**”).

NOW, THEREFORE, in consideration and for the promises and covenants and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor agrees to assign and hereby assigns, transfers, and conveys to Assignee, its successors and assigns, all of Assignor’s right, title and interest throughout the world in, to, and under the Trademarks together with:

(i) all common and civil law rights therein; and

(ii) the goodwill of the business connected with the use of and symbolized by the Trademarks;

including without limitation any and all claims and causes of action with respect to any of the foregoing, whether accruing before, on and/or after the date hereof, including without limitation all rights to and claims for damages, restitution, and injunctive and other legal and equitable relief for past, present, and future infringement, dilution, misappropriation, violation, misuse, breach or default, together with the right but not the obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.


Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States, and any official of any other country or countries foreign to the United States whose duty it is to issue trademark registrations as aforesaid, to issue any registrations to Assignee, its successors, and assigns, as assignee of the entire interest herein assigned.
