**TERMINATION AND RELEASE OF
AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY
AGREEMENT**

This **TERMINATION AND RELEASE OF AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “**Termination and Release**”) is granted as of June 12, 2023 by HealthCor Partners Fund, L.P., a Delaware limited partnership with a principal office located at 701 E. Bay Street, Suite 516, Charleston, SC 29412 (“**Agent**”) in favor of **CareView Communications, Inc.**, a Nevada corporation with a principal office located at 405 State Highway 121, Suite B-240, Lewisville, TX 75067 (“**CareView NV**”), **CareView Communications, Inc.**, a Texas corporation with a principal office located at 405 State Highway 121, Suite B-240, Lewisville, TX 75067 (“**CareView TX**”) and **CareView Operations, LLC**, a Texas limited liability company with a principal office located at 405 State Highway 121, Suite B-240, Lewisville, TX 75067 (“**CareView LLC**” and together with CareView NV and CareView TX, the “**Debtors**”). Capitalized terms used herein without definition shall have the meanings respectively ascribed to them in the Agreement (as defined below).

WHEREAS, the Debtors executed and delivered an Amended and Restated Intellectual Property Security Agreement, dated as of February 17, 2015 (the “**Agreement**”), granting to the Agent for the ratable benefit of the Secured Parties a security interest in all of their right, title and interest, whether presently existing or hereafter acquired, in, to and under the Collateral, notice of which was recorded with the United States Patent and Trademark Office (“**USPTO**”) on February 18, 2018 at Reel 035014, Frame 0408,

WHEREAS, the Debtors have requested that the Agent hereby terminate, release and discharge fully, on behalf of itself and the Secured Parties, its security interests in and liens on all right, title and interest of the Debtors in, to and under all of the Collateral as herein provided; and

WHEREAS, the Debtors have requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the Collateral as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. without recourse, representation or warranty of any kind, (a) terminates the Agreement and (b) releases, terminates and discharges fully all liens and security interests thereunder in the Debtors’ right, title and interest in, to and under the Collateral, including, without limitation, the Patent Registrations and Patent Applications set forth on Schedule A hereto, the Copyright Registrations and Copyright Applications set forth on Schedule B hereto, the Trademark Registration and Trademark Applications set forth on Schedule C hereto and the Licenses set forth on Schedule D hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.


