**TERMINATION AND RELEASE OF
NOTICE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

This Termination and Release of Notice of Grant of Security Interest in United States Trademarks (this “*Release*”) dated as of October [24], 2022, is made with regard to that certain Notice of Grant of Security Interest in United States Trademarks entered into as of October 29, 2021 (as amended from time to time, the “*Grant*”), by and between WEBSTER BANK, NATIONAL ASSOCIATION, as Administrative Agent (the “*Grantee*”), and CYBERRISK ALLIANCE, LLC, a Delaware limited liability company (the “*Grantor*”). Capitalized terms not otherwise defined herein shall have the meanings ascribed to such terms in the Grant.

WHEREAS, the Grantee agreed to make certain advances of money and to extend certain financial accommodations to the Grantor in the amounts and manner set forth in that certain Amended and Restated Guarantee and Collateral Agreement, dated as of October 29, 2021, by and between the Grantee and Grantor (as amended to date, the “*Security Agreement*”).

WHEREAS, pursuant the Security Agreement, the parties entered into the Grant which was recorded on October 29, 2021 at Reel 7477, Frame 0629 in the Trademark division of the U.S. Patent and Trademark Office, the Grantor granted the Grantee a security interest in certain trademarks, trademark registrations and trademark applications (the “*Marks*”) listed in the Schedule A hereto;

WHEREAS, the Grantor has paid and satisfied in full its Obligations under the Credit Agreement, and the parties desire to enter into this Release to confirm that the Grantee has released its security interests in and to the intellectual property collateral and to expunge any recordation of the security interest insofar as it pertains to the intellectual property collateral.

NOW, THEREFORE, for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee forever releases and discharges the entire security interest in and to all of the intellectual property collateral granted to the Grantee by the Grant.


