NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does confirm that it has assigned and hereby does assign, transfer, and convey unto Assignee, its successors and assigns, absolutely and forever, all of Assignor's common law and statutory right, title and interest in and to the Trademarks in the United States of America and its territories and possessions, including the U.S. Registrations therefor shown in Schedule A, together with the entire business, which is ongoing and existing, along with the goodwill of the business symbolized by the Trademarks being assigned, and all causes of action for any and all past infringements of the rights being assigned and the right to collect and retain the proceeds therefrom, effective as of November 30, 2019.
