**RELEASE OF TRADEMARK SECURITY AGREEMENT**

May 12, 2023

WHEREAS, pursuant to that certain Amended and Restated Trademark Collateral Assignment and Security Agreement, dated October 25, 2011 (as amended by Amendment No. 1 to Amended and Restated Trademark Collateral Assignment and Security Agreement, dated as of February 26, 2014, Amendment No. 2 to Amended and Restated Trademark Collateral Assignment and Security Agreement, dated June 24, 2016 which was filed on July 6, 2016 with the United States Patent and Trademark Office in Reel: 5828; Frame: 0952, Amendment No. 3 to Amended and Restated Trademark Collateral Assignment and Security Agreement, dated as of December 14, 2020 which was filed on December 14, 2020 with the United States Patent and Trademark Office in Reel: 7150; Frame: 0069, and as further amended, restated, supplemented or otherwise modified as of the date hereof, the "Trademark Security Agreement"), TA OPERATING LLC, a Delaware limited liability company ("TA Operating"), GIRKIN DEVELOPMENT, LLC, a Kentucky limited liability company ("Girkin"), and QSL OPERATING LLC, a Maryland limited liability company ("QSL Operating"); and together with TA Operating and Girkin, each a "Releasee" and collectively, "Releasees"), created in favor of WELLS FARGO CAPITAL FINANCE, LLC, in its capacity as agent (in such capacity, together with its successors and permitted assigns, "Releasor"), a security interest in all of the Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its security interest in the Collateral.

NOW, THEREFORE, in consideration of the foregoing, intending to be legally bound and for other good and valuable consideration, the sufficiency of which is hereby acknowledged, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby (i) terminates, releases, relinquishes and discharges its security interest in the Collateral, including without limitation, all of Releasee's right, title and interest in and to the Trademarks listed on Schedule 1 hereto, and (ii) reassigns, transfers and conveys to the Releasee any right, title and interest of the Releasor in the Collateral, in each case, without recourse or representation or warranty, express or implied, of any kind.
3. Authorization. Releasor hereby authorizes Releasee or Releasee's agent to record this Release of Trademark Security Agreement with the United States Patent and Trademark Office.
