TERMINATION AND RELEASE OF  
TRADEMARK SECURITY AGREEMENT

This TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination and Release"), dated as of June 21, 2023, is made by FIRST-CITIZENS BANK & TRUST COMPANY (successor by purchase to the Federal Deposit Insurance Corporation as Receiver for Silicon Valley Bridge Bank, N.A., as successor to Silicon Valley Bank) (the "Administrative Agent") in favor of INETICO, LLC (f/k/a INETICO Acquisition, LLC), a Delaware limited liability company (the "Grantor"). Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings assigned to such terms in the Security Agreement (as defined below) or the Trademark Security Agreement (as defined below), as applicable.

WITNESSETH:

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of August 16, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), among, *inter alios*, the Grantor and Silicon Valley Bank (predecessor to the Administrative Agent), the Grantor executed that certain Trademark Security Agreement, dated as of August 16, 2017 (the "Trademark Security Agreement"), recorded with the United States Patent and Trademark Office on August 16, 2017 at Reel 006131, Frame 0214, pursuant to which the Grantor granted a continuing security interest to the Administrative Agent, for the benefit of the Lenders, in all right, title and interest of such Grantor's Intellectual Property (collectively, the "IP Collateral"), including certain Trademarks listed on Schedule A hereto and made a part hereof.

WHEREAS, Grantor's obligations under the Security Agreement, Trademark Security Agreement, and any related agreement, have been satisfied in full.

WHEREAS, the Administrative Agent now desires to terminate the Trademark Security Agreement and terminate and release its security interest in the IP Collateral and reassign any and all rights, title and interest in the same to the Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Administrative Agent hereby unconditionally, irrevocably and absolutely, terminates the Trademark Security Agreement and irrevocably discharges, terminates and releases its lien on and security interest in all of the Grantor's right, title and interest in and to the IP Collateral, including those Trademarks set forth on Schedule A hereto and all terms and conditions set forth in the Trademark Security Agreement shall be of no further force or effect.

2. The Administrative Agent hereby assigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Administrative Agent, any and all of the Administrative Agent's right, title and interest in and to the IP Collateral, including those Trademarks set forth on Schedule A hereto.

3. The Administrative Agent authorizes and requests that the Commissioner of the United States Patent and Trademark Office and any other applicable government authority record this Termination and Release.

4. This Termination and Release and the rights and obligations of the parties hereto shall be governed by and construed and interpreted in accordance with the laws of the State of California and shall be binding upon the parties' representatives, successors, assigns and transferees.
