**RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks (“Trademark Release”) is made as of June 22, 2023, by **DEUTSCHE BANK AG NEW YORK BRANCH**, a German banking corporation (the “Collateral Agent”) in favor of **GTAT CORPORATION**, a New Hampshire corporation with an address at 5 Wentworth Drive, Unit 1, Hudson, New Hampshire 03051 (the “Grantor”).

W I T N E S S E T H:

WHEREAS, the Grantor entered into a certain trademark security agreement dated January 14, 2022 with Collateral Agent, notice of which was recorded on January 20, 2022 at the United States Patent and Trademark Office (the “USPTO”) at Reel 7563, Frame 0305 (the “Trademark Security Agreement”).

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, the Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to its Trademark Collateral, including the Trademarks listed in Schedule 1.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in the Trademarks listed in Schedule 1 as herein provided.


NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any and all of its interest in the Trademarks listed in Schedule 1 hereto, and assigns, transfers and conveys to the Grantor (in each case, without any recourse to, or any representation or warranty by, the Collateral Agent) any interest in such intellectual property, including the Security Interest.
