2. confirms that the Lender has no remaining interest whatsoever in the intellectual property set forth on Schedule A, nor in any other assets owned by the Company;
3. confirms that a copy of this Termination and Release of Security Interest shall be deemed a full legal and formal equivalent of any like document that may be required in any country for any purpose;
4. authorizes and requests the Commissioner of Patents and Trademarks of the United States of America to note and record the existence of the termination and release hereby given; and
5. authorizes the filing of this Termination and Release of Security Interest in the United States Patent and Trademark Office.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE
