TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement is entered into as of June 1, 2023 (“Effective Date”) by and between United HealthCare Services, Inc. (“Assignor”), a Minnesota corporation with offices at 9900 Bren Road East, Minnetonka, Minnesota 55343, in favor of UnitedHealth Group Incorporated (“Assignee”), a Delaware corporation with offices at 9900 Bren Road East, Minnetonka, Minnesota 55343.

WHEREAS, Assignor owns the mark identified at Exhibit A (hereinafter the “Mark”).

WHEREAS, Assignee desires to acquire the Mark and all rights in the Mark, including the goodwill of the business associated with the Mark, as well as any and all common law rights in the Mark, and the trademark applications and registrations associated with the Mark;

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

Assignor hereby conveys, transfers, and assigns to Assignee, as the successor to the portion of the ongoing and existing business to which the Mark pertain, all right, title, and interest in and to the Mark, including but not limited to all common law rights in the Mark and the applications and registrations for the Mark, together with the goodwill of Assignor’s business connected with the use of and symbolized by the Mark, and all rights corresponding thereto throughout the world. Assignor further assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Mark.

Assignor agrees that at any time and from time to time after execution of this assignment, at the request of Assignee and without further consideration, Assignor will execute and deliver such other instruments and take such action as Assignee may reasonably request to transfer, convey, and assign to Assignee, and to confirm Assignee’s right, title, and interest in and to the Mark, and to assist Assignee in exercising all rights with respect to the Mark.

Nothing in this assignment, express or implied, is intended or will be construed to confer upon, or give to, any person or entity, other than the parties to this assignment, any rights, remedies, obligations, or liabilities. This assignment will bind and inure to Assignee and Assignor and their respective successors and assigns. This assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same.
