**RESOLVED:    THAT ARTICLE I – NAME & LOCATION AND & ARTICLE XX - OFFICIAL SEAL, OF THE BYLAWS OF THIS CREDIT UNION BE AMENDED TO READ AS FOLLOWS:**

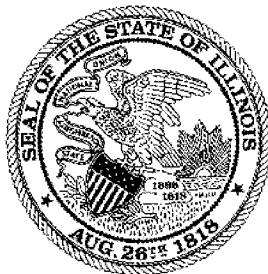
**Article I**            The name of this corporation shall be “CONSUMERS CREDIT UNION.” It shall be located in the City of Gurnee, County of Lake, in the State of Illinois.

**Article XX**            The official seal of the credit union shall be a disc with the words “CONSUMERS CREDIT UNION” and the name of the city in the margin, and the words "Corporate Seal" in the center, and the Secretary shall be responsible for its custody and safekeeping.
