NOTICE OF RELEASE OF SECURITY INTEREST IN TRADEMARKS

Reference is made to that certain Intellectual Property Security Agreement, dated as of October 19, 2020 (the "IP Security Agreement") by and between **CIT Bank, N.A.** ("Collateral Agent") and **Silver Creek Industries LLC** ("Grantor"), executed by the parties pursuant to that certain Pledge and Security Agreement dated as of October 19, 2020 (the "Pledge and Security Agreement").

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office (the "USPTO") on November 6, 2020, at **Reel 007099, Frame 0547 through Frame 0554**, pursuant to which IP Security Agreement Grantor granted to Collateral Agent for the benefit of the Secured Parties (as defined in the Pledge Agreement) a security interest in all right, title and interest of Grantor in and to the trademarks and trademark registrations therefor listed on Schedule A hereto (the "Trademarks");


WHEREAS, in accordance with the provisions of the Pledge and Security Agreement, the IP Security Agreement, and other agreements ancillary thereto, Collateral Agent wishes to release the security interest in the Trademarks and provide a document suitable for recording with the USPTO, for purposes of recording the release, relinquishment and discharge of its security interest in the Trademarks;

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Collateral Agent hereby terminates, relinquishes, releases and discharges its security interest in all of Grantor's right, title and interest in the Trademarks, including but not limited to (a) all goodwill associated with or symbolized by the Trademarks; (b) all rights in the foregoing provided by international treaties or conventions, (c) all rights corresponding thereto throughout the world; (d) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; (e) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Trademarks of or arising from any of the foregoing; and (f) all other rights of any kind whatsoever of Collateral Agent accruing thereunder or pertaining thereto, in each case without representation or warranty of any kind, express or implied.

Collateral Agent authorizes and requests that the Commissioner of the USPTO record this Notice of Release.

This Notice of Release shall be governed by, and construed in accordance with, the laws of the State of New York.


