**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of June 23, 2023 by **SILICON VALLEY BANK, A DIVISION OF FIRST-CITIZENS BANK & TRUST COMPANY** (successor by purchase to the Federal Deposit Insurance Corporation as Receiver for Silicon Valley Bridge Bank, N.A. (as successor to Silicon Valley Bank)), as Administrative Agent (the “*Assignee*”), in favor of **PH GROUP HOLDINGS CORP.**, a Delaware corporation (“*Holdings*”), **PRIVIA HEALTH, LLC**, a Delaware limited liability company (“*Borrower*”), **PRIVIA MANAGEMENT COMPANY, LLC**, a Delaware limited liability company (“*Privia Management*”), **PRIVIA MANAGEMENT COMPANY OF NORTH TEXAS, LLC**, a Delaware limited liability company (“*Privia Management North Texas*”), **PQN-CENTRAL TEXAS, LLC**, a Delaware limited liability company (“*PQN-Central*”), **PRIVIA MANAGEMENT COMPANY OF GEORGIA, LLC**, a Georgia limited liability company (“*Privia Management Georgia*”), **PQN-GEORGIA, LLC**, a Georgia limited liability company (“*PQN-Georgia*”), **PRIVIA VIRTUAL HEALTH, LLC**, a Delaware limited liability company (“*Privia Virtual*”), **PRIVIA DC METRO MANAGEMENT COMPANY, LLC**, a Delaware limited liability company (“*Privia DC*”), **WOMEN’S HEALTH MANAGEMENT COMPANY, LLC**, a Delaware limited liability company (“*Women’s Health*”), **PRIVIA QUALITY NETWORK, LLC**, a Delaware limited liability company (“*Privia Quality*”), **PRIVIA WOMEN’S SPECIALTY IPA, LLC**, a Delaware limited liability company (“*Women’s Specialty*”), **PATIENT HEALTH ADVOCACY SOLUTIONS, LLC**, a Delaware limited liability company (“*Patient Health*”), **COMPLETE MD SOLUTIONS, LLC**, a Texas limited liability company (“*Complete MD*”), and **PRIVIA QUALITY NETWORK GULF COAST II, LLC**, a Delaware limited liability company (“*Privia Gulf Coast*” and together with Holdings, Borrower, Privia Management, Privia Management North Texas, PQN-Central, Privia Management Georgia, PQN-Georgia, Privia Virtual, Privia DC, Women’s Health, Privia Quality, Women’s Specialty, Patient Health, and Complete MD, each a “*Grantor*”, and collectively, the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of November 15, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting the Assignee a security interest in and lien on certain trademarks and trademark applications (“*Trademarks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on November 18, 2019, at Reel 6798, Frame 0289;

**WHEREAS**, Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks as herein provided; and

**WHEREAS**, Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the certain Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Grant and releases, terminates and discharges all liens and security interests in Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those certain Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
