Pursuant to Title 8, Section 251 of the General Corporation Law of the State of Delaware (the “DGCL”), the undersigned corporation, in connection with the merger of RisQ, Inc., a Delaware corporation, with and into ICE Data Services, Inc., a Delaware corporation, does hereby certify as follows:

1. The name and state of incorporation of each of the constituent corporations are as follows:

2. An Agreement and Plan of Merger has been approved, adopted, executed and acknowledged by each of the constituent corporations in accordance with the requirements of Section 251 (and, with respect to each of RisQ, Inc. and ICE Data Services, Inc., by the written consent of each of their sole stockholders in accordance with Section 228) of the DGCL.

3. The surviving corporation in the merger shall be ICE Data Services, Inc., a Delaware corporation (upon the merger, the “Surviving Corporation”), and the name of the Surviving Corporation shall be ICE Data Services, Inc.

4. The merger shall become effective at 11:59 pm eastern time on May 20, 2022 (the “Effective Time”).

5. The certificate of incorporation of ICE Data Services, Inc. as in effect immediately prior to the Effective Time, shall be the certificate of incorporation of the Surviving Corporation until thereafter amended in accordance with its terms and the provisions of the DGCL.

6. The executed Agreement and Plan of Merger is on file at 32 Crosby Dr Ste 100 Bedford, MA, 01730-1448, a place of business of the Surviving Corporation.

7. A copy of the Agreement and Plan of Merger will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of any constituent corporation.
