**TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of the \_\_\_ day of June, 2023, by LIGHTHOUSE FINANCIAL CORP. (the "Secured Party"), in favor of JOHN KEELER & CO. INC., a Florida corporation ("Keeler") and COASTAL PRIDE SEAFOOD, LLC ("Coastal").

**WITNESSETH:**

**WHEREAS**, pursuant to a Trademark Security Agreement dated on or about March 31, 2021, Keeler and Coastal granted to the Secured Party a security interest in certain intangible property, including without limitation certain trademarks and other names and marks and general intangibles of like nature and trademark applications therefor and registrations thereof, all as more particularly set forth and defined in the Trademark Security Agreement (collectively, the "Trademarks");

**WHEREAS**, the security interest granted to the Secured Party was recorded at the United States Patent and Trademark Office on April 6, 2021, at Reel 7262, and Frame 0944; and

**WHEREAS**, the indebtedness secured by the Trademark Security Agreement has been satisfied in full, and Secured Party has agreed to terminate and release its security interest in all Trademarks, including without limitation the Trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party hereby terminates, releases and discharges all mortgages, liens, security interests and any other interests granted to the Secured Party by Keeler in all Trademarks, including but not limited to the following:

1. the Trademarks identified on Schedule A attached hereto;
2. the goodwill of the business connected with the use of, and symbolized by, each Trademark identified on Schedule A; and
3. the services, products and proceeds of the Trademarks identified on Schedule A, including, without limitation, any claim by Keeler against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.

The Secured Party hereby irrevocably authorizes the filing of any and all documentation Keeler deems necessary for the termination of Secured Party's lien in and security interest upon the Trademarks. This Termination and Release of Security Interest in Trademarks shall be binding upon the Secured Party and all of its predecessors, successors and assigns.

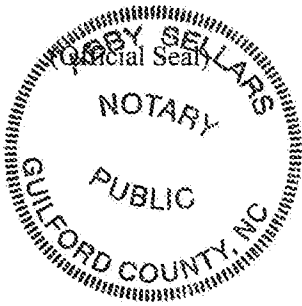


