NOW, THEREFORE, for the good and valuable consideration set forth in the Agreement, for one dollar, and for other good and valuable consideration, Assignor hereby confirms to Assignee, its successors and assigns, the ownership of the Assignor's right, title, and interest in and to all Trademarks, and hereby sells, conveys, assigns, transfers and delivers to Assignee all of Assignor's right, title and interest of every kind and character throughout the world (including, without limitation, all federal, foreign, statutory and common law and other rights therein) in and to the Trademarks, including: (i) all goodwill associated therewith; (ii) all domestic and foreign registrations therefor; (iii) all renewals and extensions of any such application, registration and filing, (iv) all income, royalties, damages, claims and payments now or hereafter due or payable under and with respect thereto, including, without limitation, damages, claims and payments for past and future infringements, misappropriations or violations thereof; (v) all rights to sue for past, present and future infringements, misappropriations or violations of the foregoing, including the right to settle suits involving claims and demands for royalties owing; (vi) all rights corresponding to any of the foregoing throughout the world; (vii) the benefit of all waivers of moral rights secured by Assignor; and (viii) the right to assign the rights conveyed herein, the same to be held and enjoyed by Assignee for its own use and benefit, and for the benefit of its successors, assigns and legal representatives (collectively, the "**Transferred Rights**").

FOR THE SAME CONSIDERATION, Assignor hereby authorizes the Commissioner of Patents and Trademarks of the United States, and any official of any other country empowered to issue trademark registrations, to record this Assignment, and to issue or transfer said Trademarks to the Assignee as owner of all right, title and interest therein, or otherwise as the Assignee may direct, in accordance with the terms of this Assignment.

FOR THE SAME CONSIDERATION, Assignor, its successors and assigns, shall execute and deliver all such further assignments or other instruments of conveyance and transfer as Assignee, its successors and assigns may reasonably request to more effectively transfer to and vest in Assignee the Trademarks and the Transferred Rights.


