## TRADEMARK ASSIGNMENT



2. Further Assurances. Assignor agrees to provide reasonable assistance to Assignee, at Assignee's cost, to evidence in every legal way, record and perfect this Assignment and to apply for and obtain recordation of and from time to time enforce, maintain and defend the assigned rights.

This Assignment may be executed in two or more counterparts, all of which shall be considered one and the same instrument and shall become effective when one or more counterparts have been signed by each of the parties and delivered to the other parties. This Assignment may be executed by facsimile or .pdf signature and a facsimile or .pdf signature shall constitute an original for all purposes.


