DECLARATION/ NAME CHANGE

I, Carolyn A. Egan, declare as follows:

1. I am Vice President for Legal Affairs and General Counsel for Florida State University and the Florida State University Board of Trustees.

2. The information in this Declaration is based on my personal knowledge and historical records of Florida State University, maintained in the ordinary course of business.

3. Florida State University is a state university established under Florida law.

4. This Declaration seeks to amend or correct the assignment records on file and/or to effectuate a name change to identify **Florida State University Board of Trustees, a public body corporate of the State of Florida** as the owner of the applications and registrations identified in Schedule A.


5. Florida Statute Section 1001.71 provides, in pertinent part, that each such university “shall be administered by a board of trustees.”

6. Florida Statute Section 1001.72 provides, in pertinent part, that “[e]ach board of trustees” for a state university “shall be a public body corporate,” and “constitutes the contracting agent of the university,” with “all the powers of a body corporate, including the power to . . . sue and be sued.” Fla. Stat. § 1001.72(1) and (3).

7. Therefore, as a matter of state law, the Florida State University Board of Trustees should be identified as owner of all trademark applications and registrations filed with the USPTO for Florida State University’s trademarks, including the trademark applications and registrations identified in the attached Schedule A.






8. The signatory being warned that willful false statements and the like are punishable by fine or imprisonment, or both, under 18 U.S.C. 1001, and that such willful false statements and the like may jeopardize the validity of the application or submission or any registration resulting therefrom, declares that all statements made of his/her own knowledge are true and all statements made on information and belief are believed to be true.
