RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of June 26, 2023, by First-Citizens Bank & Trust Company (successor by purchase to the FDIC as successor to Silicon Valley Bank) ("Bank") in favor of QUARTZY, INC., a Delaware corporation ("Grantor") with its principal place of business located at 28231 Industrial Blvd., Hayward, CA 94545.

Recital

WHEREAS Grantor granted to Bank a security interest in the trademarks described on Exhibit A attached hereto (collectively, the "Intellectual Property Collateral") under an Intellectual Property Security Agreement dated as of November 22, 2019, by and between Grantor and Silicon Valley Bank, as amended from time to time (the "Security Agreement") and recorded with the US Patent and Trademark Office on November 25, 2019 at Reel/Frame 6804/0092.

WHEREAS Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, Bank agrees to release its security interest in the Intellectual Property Collateral.
