PURCHASE AGREEMENT

This PURCHASE AGREEMENT ("Agreement") is entered into by and between HGCI, INC, a corporation organized and existing under the laws of the Nevada, with a business address of 3993 Howard Hughes Parkway, Suite 250 Las Vegas, NEVADA, 89169, UNITED STATES (hereinafter "HGCI"), and The Pots Company NV, a Naamloze Vennootschap organized and existing under the laws of Belgium, with a business address at Evolis (Kor) 100, Kortrijk, BELGIUM (hereinafter "Pots").

WHEREAS, HCGI owns certain rights in and to the trademark and trade name "ECOPOT", including U.S. Registration Number 3945569 in international class 28 (hereinafter "The Mark").

NOW, THEREFORE, the parties hereto agree as follows:

1. Pots agrees to purchase The Mark and associated goodwill for five thousand dollars (\$5000).
2. Pots hereby agrees to wire the full payment within three business days of receiving the executed assignment (attached as Exhibit A).

and WHEREAS, The Pots Company NV, a naamloze vennootschap organized and existing under the laws of BELGIUM, and having an address at Evolis (Kor) 100, Kortrijk, BELGIUM (the "Assignee"), is desirous of acquiring the entire right, title, interest in and to the TRADEMARK, together with the goodwill of the business connected with and symbolized by the TRADEMARK;

NOW, THEREFORE, in consideration of an agreed-upon sum to the ASSIGNOR, and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, ASSIGNOR transfers to ASSIGNEE, its successors and assigns, the entire right, title, interest in and to the TRADEMARK, together with the goodwill of the business connected with and symbolized by the TRADEMARK; and

ASSIGNOR authorizes the Commissioner of Trademarks of the United States or any of the states in which the TRADEMARK was or will be filed or registered, or foreign equivalent thereof, and other empowered officials, to record the transfer of the registration of the TRADEMARK to the ASSIGNEE, as assignee of ASSIGNOR's entire right, title and interest therein; and

ASSIGNOR authorizes the ASSIGNEE, its successors and assigns, or anyone it may properly designate, to apply for trademark registration or similar legal protection for the TRADEMARK, in its own name if desired, in any and all foreign countries; and

ASSIGNOR represents to the ASSIGNEE, its successors and assigns, that they have not and shall not execute any writing or do any act whatsoever conflicting with this Assignment. ASSIGNOR, its executors or administrators, will at any time upon request, without additional consideration, but at the expense of the ASSIGNEE, its successors and assigns, executes such additional writings and do such additional acts as the ASSIGNEE, its successors and assigns,



may deem desirable to perfect its enjoyment of the TRADEMARK, and render all assistance in making application for and obtaining, maintaining, and enforcing the TRADEMARK or similar legal protection in any and all countries ; and

ASSIGNOR authorizes and requests that any Official of Office of any country or countries, whose duty is to issue registrations or other evidence or forms of trademark protection on the TRADEMARK as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument; and

ASSIGNOR covenants and agrees that it has full right to convey the entire interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith; and

ASSIGNOR further covenants and agrees that it will communicate to the said ASSIGNEE, its successors, legal representatives and assigns, any facts known respecting the TRADEMARK, and testify in any legal proceeding, sign all lawful papers, make all rightful oaths, and generally do everything possible to aid the said ASSIGNEE, its successors, legal representatives and assigns, to obtain and enforce proper protection for the TRADEMARK in all countries.

ASSIGNEE hereby accepts the assignment.
