ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

June 23, 2023

WHEREAS, DSW Shoe Warehouse, Inc., a Missouri corporation (“**DSW**”), DBI Brands Management LLC (“**DBI Brands**”), an Ohio limited liability company, and ToPo Athletic LLC, a Delaware limited liability company (“**ToPo**”, and, together with DSW and DBI Brands, collectively, the “**Assignors**” and each, an “**Assignor**”) have adopted, used and is using, and holds all right, title and interest in and to, the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office or Canadian Intellectual Property Office, as applicable (the “**Trademarks**”);

WHEREAS, each Assignor and certain of its Affiliates has entered into a U.S. Security Agreement, dated June 23, 2023 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “**Security Agreement**”), in favor of The Huntington National Bank, as the Agent for itself and the other Secured Parties (as defined therein) (in such capacity, together with its successors and assigns, if any, the “**Assignee**”); and

WHEREAS, pursuant to the Security Agreement, each Assignor has assigned to the Assignee and granted to the Assignee for the benefit of the Secured Parties (as defined in the Security Agreement) a continuing security interest in all right, title and interest of such Assignor in, to and under the Trademarks, together with, among other things, the good-will of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the “**Collateral**”), to secure the payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Assignor does hereby pledge, convey, sell, assign, transfer and set over unto the Assignee and grants to the Assignee for the benefit of the Assignee (on behalf of the Secured Parties) a continuing security interest in the Collateral to secure the prompt payment, performance and observance of the Secured Obligations.


