**TERMINATION AND RELEASE OF
INTELLECTUAL PROPERTY SECURITY AGREEMENTS**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENTS** (this “*Termination and Release*”) is dated as of June 21, 2023, by **CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH** (“*Bank*”), in favor of **INMAR, INC.**, a North Carolina corporation, **INMAR ANALYTICS, INC.**, a North Carolina corporation, **AKI TECHNOLOGIES, INC.**, a Delaware corporation, **QUALANEX, LLC**, a Delaware limited liability company, **CAROLINA COUPON CLEARING, INC. (n/k/a INMAR CLEARING, INC.)**, a North Carolina corporation, **CAROLINA LOGISTICS SERVICES, LLC (n/k/a INMAR SUPPLY CHAIN SOLUTIONS, LLC)**, a North Carolina limited liability company, **CAROLINA MANUFACTURER’S SERVICES, INC. (n/k/a INMAR BRAND SOLUTIONS, INC.)**, a North Carolina corporation, **COLLECTIVE BIAS, INC. (n/k/a INMAR BRAND SOLUTIONS, INC.)**, a North Carolina corporation, **YOU TECHNOLOGY, LLC (n/k/a INMAR – YOUTECH, LLC)**, an Ohio limited liability company, **EXP PHARMACEUTICAL SERVICES CORP. (n/k/a INMAR RX SOLUTIONS, INC.)**, a North Carolina corporation and **INMAR-OIQ, LLC**, a Delaware limited liability company (collectively, “*Grantor*”).

WHEREAS, pursuant to a Second Lien Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Security Agreement*”) dated as of May 1, 2017, by and between Grantor and Bank, Grantor executed and delivered a Trademark Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof) dated as of May 1, 2017, granting, assigning and pledging to the Bank a continuing security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with the Trademark division of the USPTO at Reel 6052, Frame 0518;

WHEREAS, pursuant to the Security Agreement, certain Grantors executed and delivered a Trademark Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof) dated as of March 12, 2019, granting, assigning and pledging to the Bank a continuing security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with the Trademark division of the USPTO at Reel 6615, Frame 0405;

WHEREAS, pursuant to the Security Agreement, certain Grantors executed and delivered a Trademark Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof) dated as of January 7, 2022, granting, assigning and pledging to the Bank a continuing security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with the Trademark division of the USPTO at Reel 7555, Frame 0083;

WHEREAS, pursuant to the Security Agreement, certain Grantors executed and delivered a Trademark Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof) dated as of January 31, 2022, granting, assigning and pledging to the Bank a continuing security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with the Trademark division of the USPTO at Reel 7598, Frame 0507;

WHEREAS, pursuant to the Security Agreement, certain Grantors executed and delivered a Trademark Security Agreement (as amended, restated, supplemented or otherwise modified prior to the date hereof) dated as of April 11, 2023, granting, assigning and pledging to the Bank a continuing security interest in all of Grantor’s right, title and interest in, to certain intellectual property, which was recorded with the Trademark division of the USPTO at Reel 8051, Frame 0654;

WHEREAS, Grantor has requested that Bank hereby terminate the Intellectual Property Security Agreements as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the termination of the Intellectual Property Security Agreements as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:


1. terminates the Intellectual Property Security Agreements and releases, terminates and discharges the liens on and security interests in Grantor's right, title and interest in, to and under the intellectual property as granted in the Intellectual Property Security Agreements, including those trademarks and trademark applications identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.

THIS TERMINATION AND RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK (INCLUDING, WITHOUT LIMITATION, SECTION 5-1401 OF THE GENERAL OBLIGATIONS LAW) WITHOUT REGARD TO CONFLICTS OF LAW PRINCIPLES.
